*New rates effective April 15, 2013 (June 5, 2014 for foreign). Effective for Idaho January 1, 2014.*

**Adult (OR/WA/ID only):** \$25/year or \$65 for 3 years. Adult members receive *Northwest Chess* via periodicals mail each month. OCF, WCF or ICA state membership included.

**Junior (OR/WA/ID only):** \$19/year or \$45 for 3 years. Junior members also receive *Northwest Chess* each month. Must be under age 21 at time of expiration. OCF, WCF or ICA state membership included.

**Scholastic (OR/WA/ID only):** \$10 for 6 months. Same as junior membership, except for 6 months only. Can be converted to a regular junior membership by paying the balance before expiration.

**Family (OR/WA/ID only):** \$5/year or \$12 for 3 years (**not a subscription – membership only**). This class of membership is open only to co-residents of an Adult or Junior member. Expires at the same time. *If first member is a junior, additional family member(s) must also be juniors.*

**Subscriber (U.S. only):** \$25/year or \$65 for 3 years. For clubs and organizations or for persons living outside the Northwest. Subscribers receive *Northwest Chess* each month, but no memberships are included. Inquire about special rates for libraries and school chess clubs.

**Subscriber (Foreign):** US\$36/year (Canada) or US\$54/year (all other countries); no discounts are available. Subscribers receive *Northwest Chess* each month, but no memberships are included.
