**SUBSCRIPTION / MEMBERSHIP APPLICATION / RENEWAL FORM**

*As of February 28, 2019, Idaho residents no longer receive an ICA membership when subscribing to NWC via the website or this form. For ICA membership options, please visit the ICA website.*

**Adult (OR/WA only):** \$30/year or \$80 for 3 years. Adult members receive *Northwest Chess* via periodicals mail each month. OCF or WCF state membership included.

**Junior (OR/WA only):** \$24/year or \$43 for 2 years. Junior members also receive *Northwest Chess* each month. Must be under age 21 at time of expiration. OCF or WCF state membership included.

**Scholastic (OR/WA only):** \$14 for 6 months. Same as junior membership, except for 6 months only. Can be converted to a regular junior membership by paying the balance before expiration.

**Senior:** \$25/year or \$65 for 3 years. Senior members also receive *Northwest Chess* each month. Must be age 65 or over. OCF or WCF state membership included if applicable.

**Family (OR/WA only):** \$10/year, \$18 for 2 years (with \$43 junior primary membership) or \$25 for 3 years (**not a subscription – membership only**). This class of membership is open only to co-residents of an Adult, Senior or Junior member. Expires at the same time. *If first member is a junior, additional family member(s) must also be juniors.*

**Subscriber (U.S. only):** \$30/year or \$80 for 3 years. For clubs and organizations or for persons living outside the Northwest (WA/OR). Subscribers receive *Northwest Chess* each month, but no memberships are included. Inquire about special rates for libraries and school chess clubs.

**Subscriber (Foreign):** US\$40/year (Canada) or US\$60/year (all other countries); no discounts are available. Subscribers receive *Northwest Chess* each month, but no memberships are included.
